These risks may arise from the improper or negligent operation and use of facilities and equipment, the act, or omissions of others (including theft of personal property by guests or third parties), as well as undertaking activities which may exacerbate physical limitations and pre-existing conditions. You understand and agree that it is your sole responsibility to determine your abilities, conditioning levels, physical limitations, and the suitability of exercise, and/or swim activity.

BY ENTERING MEADOWBROOK SWIM AND TENNIS AT MONTEREY BAY, YOU ASSUME THE RISK OF ALL LOSS, DAMAGE, INJURY, OR DEATH WHICH MAY IN ANY WAY ARISE FROM OR IS ASSOCIATED WITH PARTICIPATION IN ANY ACTIVITY OR USE OF ANY AND ALL AREAS, EQUIPMENT AND FACILITIES. YOU HEREBY WAIVE, RELEASE FROM LIABILITY, AND COVENANT NOT TO SUE MEADOWBROOK SWIM AND TENNIS AT MONTEREY BAY, (LLC.), ITS AGENTS, ASSOCIATES, OFFICERS, AND DIRECTOR, FOR ANY LIABILITY TO YOU, YOUR HEIRS, OR ALL OTHER INDIVIDUALS TO WHOM YOU HAVE EXPRESS OR IMPLIED RESPONSIBILITY, WHICH MAY IN ANY WAY ARISE OUT OF, RELATE TO, OR BE ASSOCIATED WITH THE PARTICIPATION IN ANY ACTIVITY OR USE OF THE POOL, SPA, FITNESS ROOM, EQUIPMENT, AND TOTAL FACILITIES OF MEADOWBROOK SWIM AND TENNIS AT MONTEREY BAY. YOU ARE AWARE THAT THIS RELEASE OF LIABILITY, A WAIVER OF YOUR LEGAL RIGHT TO COLLECT DAMAGES IN THE EVENT OF INJURY, DEATH, OR PERSONAL PROPERTY DAMAGE, AND AN AGREEMENT NOT TO SUE MEADOWBROOK SWIM AND TENNIS AT MONTEREY BAY.

Additionally, you are aware that any participation includes possible exposure to and illness from infectious diseases including but not limited to **MRSA, influenza, and COVID-19**. While rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and, YOU KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES (Meadowbrook Swim and Tennis at Monterey Bay and affiliated personnel) or others, and assume full responsibility for your participation; and, willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.
